- Dr. Trujillo visited Roskruge and went into nearly every classroom. He was very impressed and had many positive things to say about the instruction and the student work that was displayed. He also noticed that we have recruited highly skilled teachers.
- We will have a Title 1 walkthrough next week.
- The open monitor position has been filled. We still have an open custodian position.
- Our Title 1 literacy night, Noche de Cuentos, will take place on October 21st.

School Store Fundraiser Committee Report

- Pumpkin Patch- Ms. Hoffman reported that the Pumpkin Patch company said we can run the fundraiser for one day only. Ms. Padilla offered to take the day off to run the event and/or to coordinate volunteers. Ms. Padilla will talk with Ms. Perez and Ms. Carranza to select a date based on the testing schedule.

VI. New Business:

- Mr. Urbina requested that PTA loan the folklorico classes \$2,150.00 to purchase new dresses. The folklorico fundraiser is on track to raise more than enough to pay back the amount and he will reimburse the PTA after they receive their check in November. Mr. Lopez moved that PTA loan the \$2,150.00 to purchase the dresses. Ms. Padilla seconded, and the motion carried.
- Mr. Urbina requested that PTA cover expenses to host a monthly PBIS student recognition for middle schoolers. Each teacher will select one student who demonstrates positive behavior to attend a reception with donuts and milk. The selected students may bring one guest. Ms. Padilla moved that PTA allocated up to \$100.00 per month to pay for the receptions. Ms. Grunloh seconded the motion, and it carried.
- Ms. Hoffman moved that PTA allocate up to \$200.00 to cover costs associated with Noche de Cuentos, including snacks and giveaways. Ms. Padilla seconded the motion, and it carried.
- Ms. Salinas requested that PTA cover the cost to make alterations to mariachi trajes. Ms. Perez moved that PTA allocate \$300.00 to cover the costs. The motion was seconded by Ms. Grunloh, and it carried.
