II. Call to order: Meeting called to order at 5:40pm.

III. Approve minutes from 9/22/2025 meeting: The minutes were posted to the website. There being no objections or corrections, the minutes were approved as submitted.

IV. Reports:

President's Report

Treasurer's Report

• Ms. Bly reported that the bank statement and money minder balances were the same. PTA has had income in excess of \$17,000, and expenses of \$5,000. The balance on October 27th, 2025 is \$42,575.75. The \$2,150.00 loaned to the folklorico club has been paid in full thanks to a generous donation. A California visitor donated \$1,000.00 to Las Pumas de Roskruge mariachi.

Principal's Report

Mrs. Carranza reports that

- About 50 teachers of English from Universidad de Sonora will be visiting soon.
- Teacher observations are in progress.
- Spirit week is this week.
- Ms. Avila is gone, a replacement is being sought.
- Sports programs are in full swing.
- There will be a middle school dance.
- Mrs. Fletcher's classes have been creating alebrijes and their work will be on display again at Tohono Chul park.
- Mrs. Grunloh is taking students to a Live Theater Workshop performance of Loteria.
- 6th grade has a field trip to the University of Arizona for Dia de los Muertos.
- The security gates are working, they will be fully operational soon with card access.

- Juanita Cortez asked that two new high chairs be purchased for the front office. Mrs. Carranza moved to allocate no more than \$500.00 from the general fund to purchase the chairs. Mrs. Padilla Rivera seconded the motion. There being no objection or further discussion, the motion carried.
- The Fourth Avenue Street Fair is coming up. Please spread the word. It will be on December 12th, 13th, and 14th, 2025.

V. Old Business:

- Bumper stickers- Mrs. Fletcher moved that no more than \$315.00 from the General Fund be made available to cover the cost. Mrs. Carranza seconded the motion. There being no objection or further discussion, the motion carried.
- Roskruge Hall of Fame- The item was tabled as Mr. Lopez was not at the meeting.
- Pumpkin Patch Holiday store- The holiday store is scheduled for one day, December 5th, 2025. Mrs. Bly will review and sign the agreement. It is possible that the gift of an inflatable movie screen will be made available to Roskruge.
- Folklorico club loan- The loan for the folklorico dresses has been repaid.
- Invitations have been sent for the PBIS student of the month breakfasts. Each student may bring one adult.
- Noche de Cuentos- the event was well attended. PTA previously authorized up to \$200 to cover costs. Ms. Hoffman reported that her budget was over by \$18.38. By consent, the additional \$18.38, paid from the community representative account, was approved.
- Square 1 Art- Mrs. Fletcher reported that there has not been much follow through from the teachers who were initially enthusiastic. She will continue to push this fund-raising art idea for the next two weeks but will not renew it for the Spring semester.

VI. New Business:

- Reimbursement for Strengthening Families childcare (\$75.00)- Mrs. Romero was not paid for her services because at the last minute, childcare was not needed. Ms. Hoffman paid the sum of \$75.00. Mrs. Carranza moved to reimburse the amount. The motion was seconded by Mrs. Fletcher. There being no objection or further discussion, Ms. Hoffman will be reimbursed the \$75.00. Should this occur again, Ms. Hoffman will let the PTA know.
- Increase allowance for Noche de Cuentos (\$18.38)- This matter was covered under Old Business.

VIII. Call to Audience

 Mrs. Perez advises that Danielle Rodriguez was asked to pay \$5.00 for a coaching license and moved that the \$5.00 be reimbursed to her. Mrs. Carranza seconded the motion. There being no further discussion or objection, the motion carried. Ms. Rodriguez will be reimbursed for her expense.
